



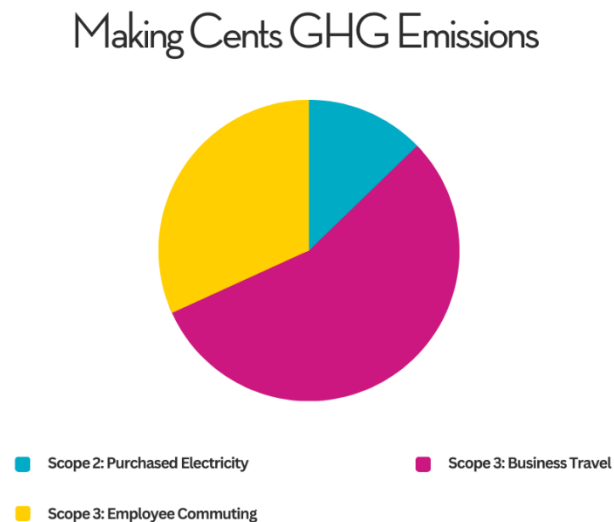

2022 Greenhouse Gas Emissions Report

Making Cents International measured and established a baseline of our greenhouse gas emissions for calendar year 2022 for all facilities leased and controlled by the company.

This Greenhouse Gas (GHG) Emissions Report provides measurement of our Scope 1 and Scope 2 emissions, as well as our Scope 3 emissions for FY 2022. Making Cents attests that the Scope 1, 2 and 3 GHG emissions were calculated in accordance with the GHG Protocol Corporate Accounting and Reporting Standard.

In calendar year 2022, Making Cents' Scope 2 emissions measured approximately 4.42 metric tons CO₂e. Its Scope 3 emissions measured approximately 30.91 metric tons CO₂e. The entirety of Making Cents' emissions is from the electricity used in the two facilities we occupied in 2022, which include a commercial office space and a WeWork space in Washington DC; and from employee business travel and commuting.



Reduction Targets

Making Cents is committed to further reducing our GHG emissions and our impact on the climate and will work to establish annual reduction targets and other relevant sustainability goals.
